# FURTHER INFORMATION ABOUT THE EARLY YEARS PUPIL PREMIUM

#### WHAT IS THE EARLY YEARS PUPIL PREMIUM?

It is additional funding to support disadvantaged three and four year olds receiving the Free Early Education Entitlement.

#### WHY SHOULD I COMPLETE THIS FORM?

From January 2015 all children in Bristol who are aged three and four years and are accessing the Free Entitlement and whose parents/guardians meet the criteria set out above will be eligible for the Early Years Pupil Premium. By applying for the Early Years Pupil Premium, you are helping us to claim additional funding for your child's early education.

#### **HOW MUCH MONEY WILL IT RAISE?**

Registering your child for the pupil premium could raise an extra £300 per child per year for us to fund valuable support, like extra training for staff.

## IF MY CHILD IS ELIGIBLE, WILL THIS MONEY BE DEDUCTED FROM MY INVOICE?

No. The Early Years People Premium funding comes directly to us to be used for your child's early education.

#### **HOW WILL MY PERSONAL INFORMATION BE USED?**

The information you provide in this form will be passed to Bristol City Council to determine whether your child is eligible for the pupil premium only. The information may also be shared with other Council departments to offer benefits and services. You only need to complete this form once and it will last for the duration of your child's time here.

Bristol City Council is committed to ensuring that the personal and sensitive information that is held about you is protected and kept safe and secure, and has measures in place to prevent the loss, misuse or alteration of your personal information.

#### **BRISTOL CITY COUNCIL - THE DATA PROTECTION ACT 1998**

FAIR PROCESSING NOTICE (schedule 1 section 2 subsection 1(a) & section 3)

Local education authorities hold information on pupils in order to run the education system, and in doing so must follow the Data Protection Act 1998. This means, amongst other things that the data held about pupils will only be used for specific purposes allowed by law. We are therefore writing to tell you about the types of data held, why that data is help and to whom it may be passed.

The Local Education Authority (LEA) uses information collected about pupils to carry out specific functions for which it is legally responsible, such as the assessment of any special educational needs the pupil may have, home to school transport, school admissions, pupil welfare, children looked after, exclusions, early years support etc.. Information collected on pupils may also be exchanged with other departments in the Council, and other public bodies (for example, the Local Health Authority) where this is required for statutory purposes or is deemed to be of benefit to the pupil. The LEA also uses the information to derive statistics to inform decisions on (for example) the funding of schools, and to assess the performance of schools and set targets for them. The statistics are used in such a way that individual pupils cannot be identified from them.

Information on individuals held on computer systems may be kept for up to eight years after they have left school.

Pupils, as data subjects, have certain rights under the Data Protection Act, including a general right of access to personal data held on them, with parents exercising this right on their behalf if they are too young to do so themselves.
